RECOGNITION ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993, SVITM TEACHERS EDUCATION, PLOT NO.314, 318, STREET: SADA BYPAS, VILLAGE: NIRAWALI, P.O. BARAUA, TEHSIL/CITY: GWALIOR, DISTRICT: GWALIOR- 474010, MADHYA PRADESH (WRCAPP1129) had submitted on 29.09.2010 the application to the Western Regional Committee of the NCTE for grant of recognition for starting the D.El.Ed. Course for an annual intake of 50 seats.

- 2. AND WHEREAS, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution has adequate financial resources, accommodation, library, qualified staff, laboratory and that it fulfills such other conditions required for proper-functioning of the institution D.El.Ed. course as determined by regulations.
- NOW THEREFORE, in exercise of the powers vested Under Section 14 (3) (a) of the NCTE Act, 1993, the Western Regional Committee hereby grants recognition to SVITM TEACHERS EDUCATION, PLOT NO.314, 318, STREET: SADA BYPAS, VILLAGE: NIRAWALI, P.O. BARAUA, TEHSIL/CITY: GWALIOR, DISTRICT: GWALIOR- 474010, MADHYA PRADESH for starting the D.El.Ed Course of 2 Year with an annual intake of 50 (Fifty) seats from the academic session 2014–2015, in the light of Hon'ble Supreme Court Order dt. 13-12-2012, in WP.(Civil) 276/2012.
- Further, the institution is required to comply with all post-recognition conditions enumerated from Clause 8(11) to Clause 8(16) of NCTE (Recognition, Norms & Procedure) Regulations, 2009.

- The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
